MINUTES OF BOARD OF ASSESSORS' MEETING JANUARY 14, 2025

William Garreffi, Chairman called the Session to order at 4:45 p.m.in the Planning & Development Conference Room. In attendance was William Garreffi - Chairman; Mel Pauze – Board Member; John T. Curran – Director; and Lisa Henderson – Clerk.

DIRECTOR UPDATE:

We are in full swing of fiscal 2025 real estate and personal property abatement season. Approximately 43 applications have been received so far. We have received our first motor vehicle commitment of the year with roughly 53 thousand bills. We are simultaneously preparing our fiscal 2026 Income & Expense and Form of Lists for mailing. We anticipate our Income & Expense forms to be mailed around January 24th and the Forms of Lists on January 31st. These are being mailed a little earlier than usual preparation for our revaluation year with the Massachusetts Department of Revenue.
