Acting under the provisions of the Code of the Town of Barnstable, §112-1 through §112-7, the Historical Commission will hold a Public Hearing on the following applications. The following Applications <u>have been determined significant</u> and were referred to a Public Hearing:

APPLICATIONS

Charles N. Mills Trust., 131 Irving Avenue, Hyannis Port, Map 287, Parcel 066/001, built 1900, contributing building in the Hyannis Port Historic District

<u>Partial Demolition:</u> on north, west, south, and eat elevations, to include: window alterations, front entrance porch, side entrance porch, third floor walkout porch, addition of a dormer to the front of roof walk, addition of a bulkhead, demolition existing sunroom, addition of a new foundation, removal of chimney in center of roof deck.

Shay Jr., Joseph F., 76 Washington Avenue, Hyannis Port, Map 287, Parcel 096/000, built 1890.

<u>Partial Demolition</u> on the east, south, and west elevations to include: the addition of two dormers to the existing roof and replacement of two new windows from the existing window on the existing dormer seen on the east elevation, one new dormer to be viewed from the southeast, and one new dormer to be viewed from the southwest.

Zhang, Ying & Wang, Yingli, 401 Ocean Street, Hyannis, Map 325, Parcel 010/000, built 1915.

<u>Full Demolition</u>: Demolition existing multi-family residence and accessory building.

MacKinnon, Donald J., 910 Main Street, Cotuit, Map 035, Parcel 090/000, built 1922.

<u>Partial Demolition:</u> on the west, north, east, and south elevations, to include: removal of existing decks, stairs, doors, windows, sidelights, shutters, concrete foundation, remove and relocate 4 existing windows, remove roof of existing 1 story portion of house, and remove existing cantilevered portion of 1st floor.

Sheree p. Kay, Trustee of the SPK Family Realty Trust, 74 Summerbell Avenue, Centerville, Map 226, Parcel 064/000, built 1875.

<u>Partial Demolition:</u> to include the removal of wall shingles, remnants of the small side porch and stoop, along with some exterior trim.

Gould, Robert, 67 Long Beach Road, Centerville, Map 206, Parcel 019/000, built 1930.

Partial Demolition: alterations to the roof line, replace windows, remove/replace siding.

In an emergency, a public body shall post notice as soon as reasonably possible prior to such meeting. Notice shall be printed in a legible, easily understandable format and shall contain: the date, time and place of such meeting and a listing of topics that the chair reasonably anticipates will be discussed at the meeting. For meetings of a local public body, notice shall be filed with the municipal clerk and posted in a manner conspicuously visible to the public at all hours in or on the municipal building in which the clerk's office is located
