The Barnstable Committee of the Old King's Highway Historic District Committee, acting in accordance with the Old King's Highway Regional Historic District Act, Chapter 470, Acts of 1973 as amended, has held a hearing and made determinations on the following applications:

Budlong, Joyce, 40 Village Lane, West Barnstable, Map 155, Parcel 007/002, built 1997
Construct 14'X12' addition at the south elevation

Freeman, Mark, 44 Bragg's Lane, Barnstable, Map 299, Parcel 058, Cobb Carriage House, built c.1780, contributing structure in the Old King's Highway Historic District
Construct a 14'X20' shed

Floyd, Richard & Maureen, 88 Hilliard's Hayway, West Barnstable, Map 136, Parcel 037, built 2000 Construct 135sqft screened porch, add pergola, install new granite platform, create new stone stairs and fill in stone wall to match existing - all at south elevation; replace & change some windows and doors on all elevations

Leclerc, David & Pamela, 3920 Main Street, Cummaquid, Map 335, Parcel 057, Captain Joseph Smith House, built c.1827, contributing structure in the Old King's Highway Historic District
Demolish attached shed and barn

Quinn, William & Marilyn, 11 Second Way, Barnstable, Map 301, Parcel 052, built 2008
Install 22 roof mounted solar panels on the front elevation of main structure, and 6 roof mounted solar panels on the garage structure

******Certificate of Appropriateness Approved as Amended – noting the four panels on the front will be removed and six panels will be added to the garage; also the Committee has requested the applicant maintain the current vegetation where possible******

Tales of Cape Cod, 3046 Main Street, Barnstable, Map 279, Parcel 071/000, Olde Colonial Courthouse, Built 1774, contributing structure in the Old King's Highway Historic District
Install interpretive panel/standing sign on the front lawn along 6A, constructed of aluminum steel in a brown finish

******Certificate of Appropriateness Approved as Submitted noting the Committee will allow the interpretive panel to be installed anywhere along the curve at the applicants discretion******

The Committee may renew any certificate for an additional term or terms of not over one year provided application for such renewal is received prior to the expiration of said certificate.
