SHELLFISH COMMITTEE MINUTES OF THE MEETING DATE: March 12, 2025 TIME: 6:00-8:00 PM

Douglas Crook called the meeting to order at 6:00 PM, as March 12, 2025 meeting of the Shellfish Committee. Chairman Crook read a notice at the beginning of the meeting:

TOPICS FOR DISCUSSION

1. Approve Meeting Minutes: February 12, 2025 minutes

Paul motioned to approve the February 12, 2025 meeting minutes and Patricia seconded. There was a unanimous vote in favor of approving minutes as written.

- 3. Natural Resources Report / Correspondence:
 - 1. Shellfish Growing Area Updates

Effective April 1st, Shoestring Bay and the Scudder Lane recreational area will be closed.

2. Monthly Propagation Report

Constable Croteau stated that the scallop seed would be provided by Ward Aquafarms. Shellfish Biologist Liz Lewis submitted the yearly propagation report to the Division of Marine Fisheries (DMF).

The Shellfish team has been working on multiple outreach opportunities.

3. Centerville River Relays

Constable Croteau stated the Centerville River Relays are done every other year in the portions of the Centerville River permitted by DMF. Notification was shared with the Commercial permit holders as well as posted on the town's website. There will be two low tide dates; Friday May 2nd and Monday May 15th, and two high tide dates; Friday May 9th and Friday May 23rd.

4. Clamming Class for Kids 2025

Clammer Kids classes will be held June 28th and June 29th. There will be a hot pink clam again this year, and the kid who finds it will win a prize.

Oyster season and Scallop season will officially be closed April 1st.

4. New Business:

1. Dredging and Safety Issues

There was discussion on dredging and dry dragging, including comments of the dredge boats getting too close to shore and creating troughs. Concerns on areas such as West Bay were brought up, as well as suggestions of having time restrictions for dragging. Chairman Crook suggested revisiting the topic again in May.

The aquaculture site is 1.99 acres with all indigenous species allowed. Harvest is proposed to be by hand. Tim motioned to recommend the transfer and Patricia seconded. All in favor.

2. Hearing for the transfer of aquaculture licensed site ng029 from Mark Begley, 20 High St, West Barnstable, MA 02668 to Tyler Hagenstein 28 Derby Drive, West Barnstable, MA 02668 and issuance of a new license to Tyler Hagenstein for a period of 5 years. Public hearing 4/10/2025 10:00AM, Selectmen's Conference Room, second floor, Town Hall, 367 Main St. Hyannis

The aquaculture site is 2 acres. Harvest will mostly be oysters and quahogs with potential experimenting with surf clams. Natural Resource has no oppositions. Tim motioned to recommend the transfer and Paul seconded. All in favor

Proposed Project: Proposed invasive plant removal and native plant restoration to multiple areas of the property along with the construction of a reinforced high marsh system and placement of a salt marsh pillow in order to stabilize and revegetate the base of the coastal

bank

Proposed Project: The project as proposed will include grading and vegetation restoration and construction of a vinyl bulkhead to stabilize the failing Coastal Bank, and replacement of the
