**BACKGROUND:** The costs of running elections have increased substantially due to the requirements to conduct early voting and mail in ballots. Additional staffing is necessary to handle the volume of paperwork associated with the mail-in ballots. The tax work-off program has been some help in supporting this effort, but it is not enough. The costs of having police at polling locations have risen as well over the years as wage levels have increased. Additionally, materials and postage costs have increased substantially due to the mail-in ballot process.

**ANALYSIS:** The Town Clerk's operation is currently \$5,000 over budget for personnel costs and \$30,000 over budget on operating expenses. These recurring operating expenses will need to be added to the Town Clerk's base operating budget on an annual basis. The current level of funding along with this additional request should provide the operation with sufficient funds to conduct two elections a year.

**FISCAL IMPACT:** This appropriation is expected to be added to the Town Clerk's base budget in Fiscal Year 2025 and future years. Funding for this appropriation is recommended to be provided from the General Fund reserves which have a current balance of \$29,068,778.

**TOWN MANAGER RECOMMENDATION:** Mark S. Ells, Town Manager, recommends favorable action by the Town Council.

**BACKGROUND:** The Town has had a Senior Property Tax Work-Off Program in place since fiscal year 2009, when it accepted MGL c. 59, § 5K. In 2022, the Town Council voted to expand the program to include veterans by accepting MGL c. 59, § 5N. Under the programs, participating taxpayers volunteer their services to the town in exchange for a reduction in their property tax bills. Acceptance of either statute may be revoked by vote of the Town Council, but any such revocation cannot occur until at least three years after the statute was accepted.

The maximum yearly amount for both programs authorized by state law was \$1,500 until October 2023, when state law was amended to increase the maximum for seniors to \$2,000. On March 21, 2004, the Town Council voted to authorize a letter to Senator Cyr, copying the Governor and other elected officials, requesting that they amend the law for veterans to provide a similar increase. Chapter 183 of the Town Code currently references \$1,500 for both seniors and veterans. The proposed amendment would make the amount authorized by the Town consistent with the maximum amount authorized by state law.

**FISCAL IMPACT:** The ordinance caps the total number of participants in the program at 20 per year. The maximum financial exposure under this program with the new cap of \$2,000 per participant is \$46,000.

**TOWN MANAGER RECOMMENDATION:** Mark S. Ells, Town Manager, recommends approval of this item.

**BACKGROUND:** In the spring of 2024, Friends of Barnstable Harbor (FOBH) is planning to embark on a Finfish and shellfish survey in Barnstable Harbor. The study will be conducted by the Center for Coastal Studies (CSS) Marine Fisheries Director Owen Nichols and will focus on commercially and recreationally important species. Sampling methods will include trawls, beach seining, dredging, ventless lobster traps, and gillnets.

Survey work will be preceded by an outreach and engagement process during which Center for Coastal Studies staff will gather feedback from local and national resource managers, advisory groups, and stockholders, including commercial/recreational fisherman and shellfish farmers. The process will build on outreach conducted by CSS and FOBH to develop a robust marine resource survey that focuses on the species and habitats of greatest importance to the local community.

Once the project begins, the outreach and engagement process will expand and build on other community partnerships in education and community service. Students and teachers from Barnstable High School will have an opportunity to join CSS researchers in the field for hands-on learning, and undergraduate student volunteers and AmeriCorps Cape Cod Service members will assist with data collection and management.

Additionally, if relevant scientific questions arise during the outreach and engagement process, focused studies may be piggy-backed onto the planned fieldwork at a minimum additional costs, creating opportunities for additional scientific collaboration with researchers from the Massachusetts Division of Marine Fisheries and other institutions.

**ANALYSIS:** The cost of the project is budgeted at \$71,780. This will support 12 months of surveys and preparation and presentation of a report. The Center will contribute some personal costs as a matching contribution and the FOBH have raised over \$30,000 to support this research. Additional fundraising events are planned, and a fundraising appeal will be made to the FOBH membership. The requested matching contribution from the town of Barnstable is \$15,000.

**FISCAL IMPACT:** This is a one-time expense that will be provided from the General Fund reserves. Additionally, the request includes the provision of one slip in Barnstable Harbor for 18 days of data collection.

**BACKGROUND:** Munis, by Tyler Technologies, is the core financial software used by the Town. This would fund the migration of the Town's existing Munis system from on-premise servers located in Town Hall to cloud hosted Software as a Service (SaaS) solution. With this solution, all Munis software and data would reside on Tyler Technologies cloud-based servers, rather than on-site at Town Hall. This request includes a one-time cost of \$28,000 for the initial migration services, as well as an additional \$175,000 in annual support and licensing fees over and above the cost of the Town's existing Munis support contract. The cost of the existing on-premises Munis contract is \$321,000. Moving to the Munis SaaS solution would increase that annual cost by \$175,000, for a total cost of \$496,000 per year for a three-year term.

The Munis software is arguably the most critical system that the Town uses. All core financial functions for both the Town and School Department are dependent on Munis, including payroll, tax and utility billing, accounts receivable, purchase orders, and accounts payable. The existing Munis system currently runs on our on-premises servers located in Town Hall. In the event of a disaster, cyber-incident, or hardware failure, there is a risk that Munis could become unavailable for a period of time while repairs were made, and data was restored. Given the critical nature of Munis, even a short disruption in service could result in significant negative consequences for the Town's operations. More recently, the server went down and the possibility of not being able to produce the payroll was an existent situation that would have affected hundreds of employees.

**ANALYSIS:** Moving to the Munis cloud hosted SaaS solution would offer a number of advantages:

- Increased reliability and resiliency to a disaster, cyber-incident, or hardware failure – Munis would be located off-site on Tyler's fully redundant systems, with secure backups handled by Tyler
- Shifts the burden for maintenance and upgrades of hardware and software to Tyler
- Scalability and performance – rather than being tied to existing server hardware & software, Tyler is responsible for upgrading its underlying infrastructure to maintain performance levels
- Tyler provides round-the-clock on-call coverage for critical outages

Funding this request would increase the reliability and disaster-resiliency of the Town's core financial system. It would shift the burden for maintaining the hardware and software to Tyler Technologies, freeing up Town staff to work on other initiatives. It would ensure consistent levels of performance over time, with the tasks of maintaining the underlying infrastructure shifted to Tyler.

If not funded, the Town would continue using its on-premises Munis system. The Town would potentially be at risk from a disaster, cyber-incident, or hardware failure that could result in a disruption of vital business functions. The Town would continue to be responsible for the costs of upgrading and maintaining the underlying servers required by Munis.

**FISCAL IMPACT:** This appropriation would be provided from the General Fund Reserves which have a current balance of \$29,068,778. If approved, the additional \$175,000 will need to be added to the budget in FY25 and going forward to continue with the service.

**BACKGROUND:** This request would fund the purchase and maintenance of a secure data backup appliance which would greatly increase the Town's resilience against cyberattacks and enable it to recover from such an attack more quickly. This request includes the purchase and installation cost for the backup appliance hardware itself, as well as the first-year annual maintenance cost for the device and associated services.

While the Town's current backup system has worked well in the past, it has become outdated and is potentially vulnerable. Increasingly, ransomware attacks will specifically target data backups, making recovery much more difficult and time consuming. If the Town were hit with a ransomware attack now, portions of our backup system could potentially be compromised, prolonging recovery efforts.

Ransomware attacks will often initially infect a system and then wait for a period of weeks before "detonating". The result is that any backups taken since the initial infection could be compromised. We currently don't have a quick or easy way to determine when exactly an attack occurred and when the last clean backup was taken. What often happens after a ransomware attack is that data is restored from a backup that was itself infected, thereby re-infecting the network again, and prolonging the recovery time. The average recovery time for a ransomware attack is 22 days. If the Town's IT systems were down for 22 days or longer, there would likely be serious consequences for daily Town operations.

Another disadvantage with our current system is the potential compromise of sensitive data during a cyberattack. Attackers will often target sensitive data such as social security numbers and other financial information and will resell this data to other criminal organizations. Depending on what information is stolen, and how many individuals are affected, the liability costs to the Town could be high. If sensitive data was compromised through a breach, the Town could potentially be liable for fines, settlements, and credit monitoring services for those whose data was compromised. The average total cost of public sector data breaches in 2022 was \$2,070,000.

**ANALYSIS:** The secure backup appliance that would be funded with this request would mitigate many of these concerns to the extent possible. The appliance is isolated from direct network access, making it difficult for attackers to access directly. All backup data is securely encrypted through all phases of the backup process. The backups are "immutable" meaning that once they are written, they cannot be altered, such as when a ransomware attack attempts to encrypt data backups. The appliance uses AI to scan backup data for anomalies and threats. It identifies sensitive data, like personal financial data, and quantifies the exposure risk for a potential breach of this data, and it identifies when an attack occurred, and which backups are clean and safe to restore from.

Implementing this backup solution would reduce our overall risk exposure and improve our recovery time from any potential ransomware attack or other incident. It would ensure that backups are kept isolated and safe to the extent possible. It would greatly improve our ability to recover quickly from a ransomware attack, minimizing disruption to Town operations and minimizing the cost of such an attack. Implementing this solution would also satisfy many of the requirements that cyber insurance companies are looking for and would likely result in better cyber coverage and cheaper insurance rates for the Town.

**FISCAL IMPACT:** This appropriation would be provided from the General Fund reserves which have a current balance of \$29,068,778. If approved, an additional \$101,500 will need to be added to the budget in Fiscal Year 2025 and going forward to continue with the annual support and licensing that is provided with this service.

**BACKGROUND:** This program will supply the Barnstable Police Department (BPD) with a total of 87 child safety seats for distribution, at no cost, to community members that need a car seat. There will be four different types of seats available for proper fitting based on the age, height, and weight of the child.

**GRANT DETAIL:** \$7,901.10 worth of child passenger safety seats will be ordered by the Highway Safety Division Officer of Grants and Research and shipped directly from the factory to the Barnstable Police Department.

**ANALYSIS:** Acceptance of this award will enable the department to provide safety seats to community members in need of child passenger safety seats including the underserved populations.

**BACKGROUND:** The Town of Barnstable has been awarded a \$20,000 grant for the purpose of retaining consultant services to assist with interpretation and presentation of cleanup activities at the Barnstable County Fire Training Academy. This grant will provide funding to hire a Licensed Site Professional to assist the Town and the community by providing written comment, advice, and analysis to the Town and members of the community to help them better understand the disposal site assessment and cleanup activities.

**ANALYSIS:** The Barnstable Fire Training Academy is responsible for cleanup of the disposal site and disseminating information to the Town. It is required that they provide reports, scopes, and monitoring data associated with the disposal site cleanup actions. Acceptance of this grant will allow the Town to hire a Licensed Site Professional to assist the Town and the community in reviewing new documentation related to the Barnstable County Fire & Rescue Training Academy and provide them with an ongoing assessment of the adequacy of response actions and recommendations for any additional actions to protect public health, welfare, and the environment.

**FISCAL IMPACT:** This grant is a reimbursement grant in the amount of \$20,000. The Town must expend and request reimbursement of the costs. All costs associated with this grant must be expended prior to June 30, 2025.

**BACKGROUND:** This project will fund the evaluation of the Town of Barnstable's existing Town-owned stormwater culverts for the purposes of developing an Asset Management Plan. The Clean Water State Revolving Fund will provide a grant in the amount of up to \$120,000 or 60% of the total project cost. The additional \$80,000 appropriation request is for the purpose of funding the Town's required match for 40% of the anticipated total cost.

**ANALYSIS:** The Town of Barnstable has many Town-owned culverts. However, a complete inventory of these culverts does not exist, and their respective condition is unknown. This project will identify and evaluate the culverts within the Town's stormwater drainage network to develop a risk-based culvert asset management plan and capital improvement planning methodology that will support decision makers. The project is anticipated to be completed over an 18-month period.

**FINANCIAL IMPACT:** This is a reimbursement grant for \$120,000. The Town must expend the funds upfront and subsequently submit for reimbursement. The Town's match funds for this project will be provided from the General Fund reserves which has an available balance of \$29,068,778.

**TOWN MANAGER RECOMMENDATION:** Mark S. Ells, Town Manager, recommends approval of this appropriation order and grant expenditure.

**BACKGROUND:** The Town owns and operates the Hyannis Water System, which services buildings, commercial establishments, and residences in Hyannis, Hyannisport, and West Hyannisport. The Airport Commission is the operator of Cape Cod Gateway Airport pursuant to G.L. c. 90 and Section 241-10 of the Town Code.

The Airport has identified and begun to remediate a historic release of per-and poly-fluoroalkyl substances (“PFAS”) on and adjacent to the Airport in accordance with the Massachusetts Contingency Plan, 310 CMR 40.00, which release was caused in part by the use of aqueous film forming foam (“AFFF”) at the Airport pursuant to Federal Aviation Administration (FAA) requirements to test and use AFFF.

The Town has installed, or intends to install, filtration systems at various municipal water supply wells, including the Maher Wells southeast of the Airport, to remove PFAS, including PFAS associated with AFFF at the Airport, from entering the Water System, and has incurred assessment, remediation, capital and operation and maintenance costs in connection therewith, and anticipates it will continue to incur such costs.

In order to allocate responsibilities for the costs associated with PFAS Contamination of the affected Town Wells and the Water System, the Town and the Airport Commission have determined that a one-time payment by the Commission from the Airport Enterprise Fund in the amount of \$477,887 to the Town is appropriate. This figure was arrived at by calculating the Airport’s share of the responsibility for PFAS contamination of the Maher wellfield.

**FISCAL IMPACT:** The Airport Enterprise Fund reserves were last certified as of July 1, 2023 at \$13,256,059. This appropriation will be drawn from those reserves and transferred to the Water Supply Enterprise Fund where they will be used to offset costs associated with remediating PFAS contamination.

**TOWN MANAGER RECOMMENDATION:** Mark S. Ells, Town Manager, recommends approval of the transfer order.

**SUBJECT:** Order authorizing and ratifying an Intergovernmental Agreement between the Town of Barnstable and the University of Massachusetts Dartmouth for technical support of the Town's Water Quality Monitoring and Wastewater Planning and Estuary Water Quality Sampling Programs

**BACKGROUND:** The UMass Dartmouth School for Marine Science and Technology ("UMass") has provided Water Quality Monitoring and Wastewater Planning Technical Services to the Town of Barnstable for over 20 years. UMass is retained for estuary water quality sampling analytical services, pond and lake sampling analytical services, development of pond and lake management plans, and wastewater planning efforts. Utilizing UMass has ensured that the Town's wastewater planning efforts are consistent with the methodologies and models used to develop the nitrogen Total Maximum Daily Loads (TMDLs) for Lewis Bay, Halls Creek, Centerville River, Three Bays, Popponesset Bay, and Barnstable Harbor that have been approved by the Massachusetts Department of Environmental Protection. Utilizing UMass Dartmouth has allowed the Town to plan for and adapt the Comprehensive Wastewater Management Plan, develop Pond and Lake Management Plans, and continue tracking the water quality of our ponds, lakes, and estuaries. The current agreement with UMass was entered into in 2020 and has been amended to extend the term and to increase the compensation. Additional amendments are anticipated that would extend the agreement to December 31, 2025. This vote seeks ratification of the existing contract and amendments and approval of upcoming amendments through December 31, 2025. Because this contract is with a state agency, it is not subject to the procurement requirements of G.L. c. 30B, but, rather, must be approved by the Town Council as an intergovernmental agreement.

**FINANCIAL IMPACT:** The contract will be funded from a combination of Capital Improvement Project funds and Department of Public Works Operating Budget Funds as appropriate.
