BARNSTABLE RECREATION DIVISION FEE SCHEDULE/POLICIES OF RECREATION FIELDS

- 1. A seasonal permit is required for user groups utilizing any field.
- 2. Fees are assigned seasonally by the number of days per week a group utilizes a field. (See fees below)
- 3. Groups need to provide a copy of their insurance coverage with Town of Barnstable listed as additionally insured.
- 4. Permits are only valid for the dates assigned to group.
- 5. When the rental requires a police detail, the incurred fees are the responsibility of the permit holder.
- 6. Permit length of time on the field will not exceed three hours. If so, the group must pay additional fees.
- 7. The Permit Holder/Group Leader must be a Barnstable taxpayer/year round resident. If not, the group pays double the rate.
- 8. All users will be provided a key and/or keys to use field storage, unlock gate, and open trash container. User must provide their credit card information, which will be kept on file. If key is not returned within 7 days of last use of field, user will be charged the key deposit fee (\$50).
- 9. Groups working with children need to provide a list of coaches that are CORI/SORI approved.
- 10. Permits will not be issued until the application has been completed, submitted, and approved by the Recreation Director or his/her designee.
- 11. Permit Holder/Group leaders are responsible for the field/facility cleanliness and all actions of the group's participants. Any damages caused are also the responsibility of the Permit Holder/Group leader.
